Grove St., Eustis, FL. The purpose of the meeting is for consideration of an amendment to the Land Development Regulations via Ordinance No. 17-11 amending Chapter 100 of the LDR's, revising the definition of "pharmacy" to provide that dispensaries of medical cannabis shall not be considered pharmacies and that such dispensaries shall be banned and prohibited within the city limits of Eustis.
