SEC. 109-4.2. STANDARDS FOR SPECIAL ACCESSORY USES**

(e) Fences and hedges

- (1) The posts or any portion of each fence which contacts the ground shall be of a material or chemical treatment that is ground contact resistant to decay, corrosion, and termite infestation. The posts if wooden must also be pressure treated for strength and endurance.
- (2) Fences or hedges may be located in all street (or front), side and rear yards setback areas. No fences or hedges shall exceed four feet in height when placed in the front or street side setback yard. No fence located in the side or rear yard setback shall exceed a height of six feet. However, an additional two feet height will be permitted if it is of open or lattice type of construction.
- (3) In areas where the property faces two roadways, or is located in any other area construed to be a corner lot, no fence exceeding four feet above the crown of either adjacent road shall be located in the vision triangle, specified in chapter 115, and identified as clear sight zone.
- (4) Smooth side of fence shall face a right-of-way, or private road, except split rail.
- (5) A fence constructed for protection and safety from hazard by another public agency may not be subject to the aforementioned height limitations. Approval to exceed the minimum height standards may be given by the director of development services upon receipt of satisfactory evidence of the need to exceed height standards.
- (6) No fence or hedge shall be constructed or installed in such a manner as to interfere with drainage on the site.
- (7) Should the fence encroach on any public easement, the owner shall assume all expense of any necessary removal (either temporary or permanent) or relocation.
- (8) Barbed wire shall not be used in fences except in agricultural and conservation districts and except that three strands will be permitted atop fences which exceed six feet above ground and are located in heavy commercial or industrial land use districts.
- (9) This section shall not apply to fences erected by a public body, or as approved by a public body for a public utility, in the interest of public safety.
